



Backpack Camping

Backpack Campsites are located along several blue-blazed hiking trails. Backpack camping is only allowed on these designated sites, and by application only. Dispersed camping is not permitted within our parks and forests. Backpacking campsites are provided for the true backpacker only, and therefore the length of stay at any one location is limited to one night. These sites are typically available year-round, barring closures due to hazards or severe weather.
